Meetings/Training Attended

During the month of January I attended Town Board, and PFC meetings. Officer Stashek met with Nekoosa Port Edwards State Bank for a security meeting. Office Stashek and I continue our Emergency Medical Responder Training in Port Edwards.

Calls for Service, Citations, and Written Warnings

In January officers handled 65 calls for service, and issued 15 citations and 4 written warnings.

Department Activities/Announcements

I have filled the full-time vacancy in the police department with Officer Brian Upton. Brian previously served 3 years with the Adams County Sheriff's Office.

We have been accepted into the Wisconsin Internet Crimes Against Children Task Force (ICAC) this past month. The program goal is to counter the emerging threat of offenders using the Internet or other online technology to sexually exploit children. The Wisconsin ICAC Task Force is a national leader in fighting Internet crimes against children. The task force is comprised of Wisconsin Department of Justice personnel as well as police and sheriff's departments from around the state. The task force will help funding training and equipment used in these types of investigations. It also provides resources to help with the investigation of internet crimes against children.

In the upcoming month I will be looking into the possibility of finding a limited term employee to cover shifts left vacant due to an Officer being on extended leave due to a work related injury.

Vehicle Fleet/Maintenance

We had two car deer crashes in January both caused front end damage. One was on the 2010 Charger and another on the 2012 Charger. The town was responsible for \$500 on each vehicle for our insurance deductible.
