Calls for Service, Citations, and Written Warnings

During the month of July officers handled 147 calls for service, issued 97 citations and 21 written warnings.

Department Activities/Announcements

The 2005 Lund patrol boat had motor problems and was on and off the lake throughout the month due to mechanical failures. I have requested a new patrol boat in my preliminary 2015 budget. The Mercury outboard motor on the current boat is reaching the hour level in which major repairs can be anticipated to keep the motor operational.

In July officers were assigned to traffic enforcement on an overtime basis for a State funded impaired driving grant. Officers will continue to be scheduled for extra traffic enforcement shifts throughout the summer.
