### **Meetings/Training Attended**

During the month of November I attended PFC, and Town Board meetings. Officer Swiedarke and I attended the Coordinated Community Response Team meeting. Sergeant Eckstein and Officer Swiedarke attended a rabies control program Sergeant Eckstein was certified as a trained observer. Officer Stashek attended a traffic safety meeting.

### **Calls for Service, Citations, and Written Warnings**

In November officers handled 113 calls for service, and issued 13 citations.

### **Department Activities/Announcements**

We have completed updating medical supplies in the squad cars so all the supplies are the same in each vehicle. All of our oxygen tanks and scuba tanks were hydro tested to meet federal guidelines. The testing is required every five years.

The police department joined the Wisconsin State Patrol Mobile Architecture for Communication Handling (MACH) program. This program shares police vehicle locations and available resources state wide. I am currently working on installing the program in all our vehicles and training Officers on its use. I expect us to be fully operational on the system by mid- December. The software is licensed through the State Patrol and we were allowed to use it for a minimal cost of \$84.00 per year.
