Meetings/Training Attended

During the month of December I attended Town Board meetings and PFC meeting. Officers Wilson, Kirsenlohr and Winker completed Emergency Responder Training and are awaiting taking the registry test.

Calls for Service, Citations, and Written Warnings

In December officers handled 84 calls for service, and issued 18 citations and 6 written warning.

Department Activities/Announcements

A reimbursement claim has been submitted to the WIDNR for the 2015 boat patrol expenses. The net cost submitted was \$ 13,107.82. The DNR has typically reimbursed 60-70% of the cost which we usually receive in April or May. The boat patrol logged a total of 371 hours in 2015.

I encourage citizens that leave the area for an extended time during the winter months to stop at the Town Hall and complete a vacant home form. This form will allow us to contact you should anything happen at your property.

I would remind residents to be aware of ice conditions on the area lakes before traveling out on the ice. With the warm weather the tri-lakes remain open water at this time delaying the time needed for safe ice to form this season. In the past we have had vehicles go through the ice on the lakes and especially the channel between upper and lower Lake Camelot.

I will be working on filling the open full-time patrol officer position in the upcoming month.

Routine maintenance was done to the fleet during December.
