Rome Police Department Monthly Report August 2016

Meetings/Training Attended

During the month of August I attended Town Board, and PFC meetings. Officer Stashek attended the Adams County Traffic Safety Meeting. Office Upton attended instructor development which is required by the State to become certified to instruct officer training.

Sergeant Wilson and Officer Kirslenlohr attended a traffic safety seminar in which the Rome Police Department was awarded a \$1,000 which will be used on video recording equipment for the expedition replacement vehicle.

Calls for Service, Citations, and Written Warnings

In August officers handled 125 calls for service, and issued 95 citations and 81 written warnings. The Boat Patrol logged 65 hours of Patrol and issued 4 citations.

Department Activities/Announcements

The boat patrol will end their seasonal duties on Labor Day weekend. Final numbers will be totaled but our boat patrol program did have another successful year with no serious boating crashes reported on our lakes. I would like to thank the boat patrol officers for all their hard work throughout the summer.

I would like to thank the Adams County Sheriff's Office, Rome Fire Department, and Wisconsin Department of Natural Resources for all of the time they dedicated in a recent search and recovery effort on Lake Camelot.

Officer Upton will be attending training to become the Department's firearms/rifle instructor which was split away from a general firearms instructor by the State.

In the Fire Department we are looking at the elimination of several pieces of equipment that are used very infrequently. This includes a 4 passenger UTV and a HAZMAT trailer. We continue working on getting a Fire Fighter 1 class here at the Town Hall.
