Rome Police Department Monthly Report March 2017

Meetings/Training Attended

During the month of March I attended a PFC meeting, and Town Board meetings.

Calls for Service, Citations, and Written Warnings

In March officers handled 82 calls for service, and issued 9 citations and 6 written warnings.

Department Activities/Announcements

It is the time of year when the use of recreational vehicles resumes in the Town, and I would like to remind those users that they should review the legal riding areas and ensure that the units are only operated in permitted areas. Driving off trails and onto private property without permission can result in the issuance of citations and the possibility of trail closure by land owners.

The discharge of fireworks also becomes a larger issue in the warm months. With spring the fire danger is extremely high and the Rome Police Department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

The two Officers that were involved in a motor vehicle crash, responding to an emergency call for service, both remain off duty due to injuries received in the crash. Shifts continue to be filled by utilizing part time Officers. I anticipate one of the injured Officers being cleared for duty by the end of May.

I have up fitted the 2017 Ford Explorer that replaces the 2006 Expedition. I am waiting for the computer docking equipment to arrive and the vehicle will then be placed in service.

In March the P.D. was awarded a \$ 4,000 traffic equipment grant which will be used to replace aging radar units that are starting to have increased maintenance costs.

In the next month I hope to place the regulatory buoys for the 2017 boating season.

Routine maintenance was done to the fleet during March.
