Rome Police Department Monthly Report May 2017

Meetings/Training Attended

During the month of May I attended a meeting with Social Services, a PFC meeting, and Town Board meetings.

Officers completed State mandated firearms qualification training. We also attended training/meeting at Sand Valley to discuss how emergency responses will be handled on their property. I would like to thank Sand Valley for the hospitality they provided our employees during this training.

Calls for Service, Citations, and Written Warnings

In May officers handled 112 calls for service, and issued 18 citations and 15 written warnings.

Department Activities/Announcements

We put the 2017 Boat patrol on the water over Memorial Day Weekend, the patrol will work an average of 24 hours per week throughout the summer.

Over the holiday weekend I observed we still had Fireworks being discharged around the lakes. Again, I would like to continue to remind residents the Rome Police Department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

One of the Officers involved in a motor vehicle crash, responding to an emergency call for service, remains off duty due to injuries received in the crash. Shifts continue to be filled by utilizing part time Officers. The second Officer returned to full duty May 29.

In June we will complete Emergency Vehicle Training required by the State. I will be working on up fitting a 2017 Dodge Charger.

Routine maintenance was done to the fleet during May.
