## **Rome Police Department Monthly Report November 2016**

### **Meetings/Training Attended**

During the month of November I attended Town Board meetings and a PFC meeting. Officer Upton continues with EMR training. I am continuing with Fire Fighter 1 class which concludes the end of January.

### **Calls for Service, Citations, and Written Warnings**

In November officers handled 90 calls for service, and issued 6 citations and 8 written warnings.

### **Department Activities/Announcements**

Calls for service have slowed down in November which is a normal trend for the police department as we head into the holiday season. I am pleased to announce we had another successful deer hunting season with no hunting injuries reported.

I encourage citizens that leave the area for an extended time during the winter months to stop at the Town Hall and complete a vacant home form. This form will allow us to contact you should anything happen at your property.

I would remind residents to be aware of ice conditions on the area lakes before traveling out on the ice. With the warm weather the tri-lakes remain open water at this time delaying the time needed for safe ice to form this season. In the past we have had vehicles go through the ice on the lakes and especially the channel between upper and lower Lake Camelot.

I am working on setting up software in the Fire Department that will allow members to know who is available and responding to calls via the internet. I will be up fitting an unmarked 2017 Ford Interceptor that is replacing the 2006 Ford Expedition during the month of December. The 2006 Expedition will then be sold for sealed bids.

Routine maintenance was done to the fleet during November.
