Meetings/Training Attended

During the month of September I attended Town Board meetings and the Police and Fire Commission meeting. Officers Stashek, Winker, Czys and I attended the Law Enforcement Symposium in Green Lake September 8th thru 11th. Officer Upton completed Firearms Instructor classes and continues to attend Emergency Medical Responder Training at Mid- State Technical College.

Calls for Service, Citations, and Written Warnings

In September officers handled 109 calls for service, and issued 55 citations and 42 written warnings.

Department Activities/Announcements

The police department would also like to remind citizens who own seasonal property to please stop in and fill out a vacant home form before leaving their property for an extended period of time. This helps the Police Department to be aware of properties in town that are vacant and gives us accurate contact information for property owners in the event we would need to contact them in an emergency.

Regulatory markers will be removed from the lakes during the upcoming week. The patrol boats will be scheduled for winterization soon.

The Police Department 2017 budget has been completed and submitted to the treasurer.

Routine Maintenance was done to the fleet during the month of September.

In October I will be working with Chief Schmidt on ambulance contracts in the Fire Department.
