Meetings/Training Attended

During the month of February I attended Town Board, and PFC meetings. Officer Stashek met attended the Adams County Adams County Crisis Response Committee meeting (CCRT) meeting. Office Stashek and I finished our Emergency Medical Responder Training in Port Edwards and have been recertified through the State of Wisconsin.

Calls for Service, Citations, and Written Warnings

In February officers handled 73 calls for service, and issued 15 citations and 5 written warnings.

Department Activities/Announcements

The Department received a \$ 1000.00 donation from Barb Herreid and a Thank You letter.

January and February have been busy months for the police department several felony arrests were made solving several burglary, and theft cases that took place in the summer of 2015. Several individuals were also arrested and/or referred to the District Attorney's Office after a drug investigation.

I will be working in March to establish the 2016 boat patrol roster. Since we will hopefully be at full staff by this Summer I intend to also utilize our fulltime officers to assist in patrolling our lakes. This should not only increase the amount of patrol on our lakes but will also increase our DNR reimbursement due to the fulltime officer's wage being higher than part-time officers. I also will have to attend mandatory training for the boat patrol in Green Lake on March 30, 2016.

Vehicle Fleet/Maintenance

Routine maintenance to the fleet was completed. We are still awaiting the arrival of our 2016 squad car. When the new vehicle is put into service my plan is to put our 2010 Dodge Charger for sale by sealed bids.
