### **Meetings/Training Attended**

During the month of April I attended Town Board, and PFC meetings. Sergeant Wilson attended the Adams County Crisis Response Committee meeting (CCRT) meeting. Officer Kirslenlohr was licensed as an Emergency Medical Responder.

### **Calls for Service, Citations, and Written Warnings**

In April officers handled 82 calls for service, and issued 42 citations and 9 written warnings.

### **Department Activities/Announcements**

Regulatory buoys have been replaced and will be placed in the lakes for the 2016 boating season in the near future.

I continue to work on getting boat patrol staff in place for the 2016 boat patrol season. We should have four officers ready to go by Memorial Day Weekend.

The Police Department was awarded 3 grants in April for traffic enforcement from May 1, 2016 thru September 30, 2016. A speed enforcement grant for \$ 12,875.80 of which \$ 5,000 is for equipment purchases, O.W.I. enforcement grant for \$ 7,876.80, and a safety belt grant for \$ 7,876.80.

During the month of April routine maintenance was done to the fleet. The Dodge Chargers were all serviced under a warranty recall for an airbag issue.
