## Rome Police Department Monthly Report July 2016

### Meetings/Training Attended

During the month of July I attended Town Board, and PFC meetings.

Each year the State of Wisconsin requires every police officer to attend at least 24 hours of training to maintain their certification as a law enforcement officer. The fiscal year for this requirement ended on June 30th. I would like to report that all officers in the Rome Police Department met this requirement by exceeding 24 hours of professional development. I have submitted the training compliance report to the Wisconsin Training and Standards Bureau. T&S will reimburse the Town of Rome for each officer that completed the minimum 24-hours of training.

### Calls for Service, Citations, and Written Warnings

In July officers handled 164 calls for service, and issued 128 citations and 73 written warnings. The Boat Patrol logged 141 hours of Patrol and issued 16 citations.

### Department Activities/Announcements

The police department continues to try to control the discharge of illegal fireworks. We have issued several citations and are doing what we can to get the word out that with dry conditions in our area, fireworks are a disaster waiting to happen. This is still a common violation in Rome even after the July 4<sup>th</sup> holiday. We will continue our efforts to enforce fireworks regulations the best we can. Residents are urged to call the police department to report violations of illegal fireworks.

In the next month Officers will be attending various trainings to start the 2016-2017 mandatory 24 hour recertification training requirements. Officer Upton will be attending training to become the Department's firearms/rifle instructor which was split away from a general firearms instructor by the State.

In the Fire Department I will be working on getting the records reporting software current. I also will be working with the Acting Chief on consolidation of dispatch duties. A 2017 Ford Explorer Fleet was ordered to replace 620. That vehicle should arrive in the next 90 days at which time I will equip it with the necessary emergency equipment.
